West Halton and Coleby Parish Council in pursuance of the Local Government Act 1972, the Local Authorities Cemeteries' Order 1977, and other statutory powers and regulations DO HEREBY GRANT to the person(s) named overleaf, having received payment of <insert fee>, the Exclusive Right of Burial in grave space <insert plot number>, in West Halton and Coleby cemetery, as identified on the cemetery plan in possession of West Halton and Coleby Parish Council.

New regulations will not be sent to individual grantee(s), but a full copy will be published on West Halton and Coleby Parish Council web site. It is the responsibility of the GRANTEE(S) to be aware of cemetery regulations that are in force at any particular time and to abide by them.

The right of burial is granted for a period of 50 years which expires on **<insert expiry date>**. After the period of 50 years the EROB can be extended, at the owner's request, in increments of 5 years upon payment of a renewal fee of £100 (subject to change) for every 5-year renewal increment, by contacting the Clerk of West Halton and Coleby Parish Council

The Right of Burial does NOT confer the right to erect a memorial or any other item on the grave.

The Right to erect a memorial (which includes any item intended to be placed on the grave other than a wreath), must be applied for, and is paid and granted separately when applying for permission to erect a memorial.

Items placed on a grave which contravene regulations now in force, or which may from time to time be made by the Burial Authority, are liable to be removed and disposed of without notice.


